Responsibilities

- Monitoring media and blog coverage of economic and labor policy issues and identifying opportunities for advocating for fair wages
- Writing blog posts, op-eds and other media pieces making economic and policy arguments for fair wages
- Authoring short policy papers, briefing materials, fact sheets, powerpoints and talking points
- Digesting economic research and conducting basic web-based research using standard government economic datasources, and presenting both in an accessible fashion
- Using social media tools to extend message reach
- Creating content for campaign website
- Supporting other aspects of coordination and building the campaign, in coordination with other members of the campaign staff

- Bachelor's degree, preferably in a relevant social science field
- Excellent writing and communications skills
- Ability to master economic and policy arguments, and translate complex and technical material for lay readers
- Ability to produce on short deadlines, work independently and manage multiple projects simultaneously
- At least 2 years of experience writing for a policy or issue campaign, media outlet, or advocacy organization
- Background in economic justice or labor issues
